## Latest details on KHML/RMG/CPM

Kennet Heath residents can expect the next round of invoices from CPM/RMG - issued on behalf of Kennett Heath Management Limited (KHML) - to drop onto our door-mats shortly. While assurances have been given by the managing director of a developer that there will not be a significant raise for 2010, there are no guarantees.

As detailed previously, a thorough review of properties, which **do** and **do not** need to pay towards the bund maintenance has been conducted. As a result, we have been informed by the developers that action will be taken against those who should pay and haven't. At this time, we have no indications of progress of this process.

The KHRA sub-group continues and will continue to apply pressure on all parties concerned with the KHML/CPM/RMG position. The significant recent progress has been

a meeting held between the sub-group and West Berkshire Council. The aim of this meeting was to ascertain the reasons for the council's decision to:

- Ask the developers to appoint a management company to maintain parts of the bund during planning, and
- Not to retrospectively adopt the bund.

In answer to these points, it was apparent that during the West Berkshire planning process, decisions were reached where some parts of the bund were not considered to be Public Open Space (POS) such as the fields by the Moorside Community Centre. These required the alternative arrangements covered by the developers' establishment of KHML. In terms of retrospective adoption, West Berkshire Council is resolute that the bund will not be adopted as this will set a

precedent for other estates in the county.

The council did express understanding the Kennet Heath Residents' situation and are willing to support in an appropriate fashion. When the council were asked if lessons had been learnt from our situation, we were informed that lessons had been learnt. However, as the matter is outside of the council's hands once planning is approved. They cannot guarantee the same situation happening again on other estates in West Berkshire.

We are still waiting for answers to our questions to David Wilson Homes MD Kelvin Tutill and CPM/RMG technical advisor, Stuart Latta. As a result, we will continue to apply pressure to obtain the answers that we, as Kennet Heath residents, members of KHML and customers of Redrow and David Wilson Homes, deserve.

## The New Kennet Heath Residents Association

Elections for the Kennet Heath Residents Association took place at its Annual General Meeting (AGM) held on Saturday, 3 October. The formal elections followed the call for nominations through the forum and emails. Eighteen committee members were elected for the 2009/2010 committee based on the nominations received and following a hand count of attendees at the meeting and postal votes.

During the meeting thanks were extended to Bob Morgan, the KHRA chairman for the inaugural year of 2008/2009 by councillor, Owen Jeffery. Formal reports were delivered by Bob and the lead committee members on the progress of the association on each of the areas of focus for association. The new chairman, Lee Cripps, took up the role immediately after the AGM.

### The details of the Committee Framework

The committee will be in place for one calendar year – starting October and running through to September. The process for re-election should be agreed in March with elections in October

### Committee members should:

- Attend all meetings and extend apologies when they are not able to in advance of the meeting
- In line with the constitution, non-attendance at three meetings without apologies will be an effective removal from the committee.

- Committee members should be active in support of the focus areas.

### A minimum of 7 (Seven) votes will be required for approval of a project/funding

- Where possible voting should take place at committee meetings
- When this is not possible (and this should be an exception rather than the rule), the vote should be posted to KHRA section of the forum with an email sent to each steering committee member to let them know that there is a request for an approval
- Votes should be cast within 72 hours. After this time abstention will be the default position

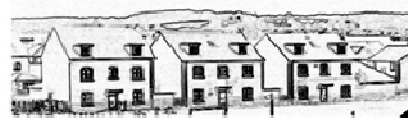
**Kennet Heath Residents' Association (KHRA)** was founded in August 2008, by a number of residents coming together with common objectives.
